

**Village of Wonder Lake Ordinance No. 34/A4**

An Amendment to Ordinance No. 034  
"Refuse - Garbage - Rubbish"  
Village of Wonder Lake, McHenry County, Illinois

---

Be it ordained by the President and the Board of Trustees of the Village of Wonder Lake, McHenry County, Illinois as follows:

Section 1. Amendment to SECTION 2.7 "The Burning of Refuse"

No person shall cause, suffer, allow or permit leaf and yard waste burning, as defined in the Section, from the hours of 10 p.m. Saturdays until 8 a.m. Fridays. Leaf and yard waste burning shall be allowed **ONLY** between 8 a.m. Friday through 10 p.m. Saturday during the twelve months of the year.

For purposes of this Section, leaf and yard waste burning shall include, but not be limited to, the combustion of leaves and yard waste, in such a way that the products of the combustion are emitted to the open air without originating in or passing through equipment for which a permit could be issued by the Illinois Environmental Protection Agency.

**Specifically prohibited** by this Section are smoldering leaf and yard waste piles between 10 p.m. on Saturdays and 8 a.m. on Fridays, which by way of combustion emit the products of the combustion into the open air.

Section 3.0 PENALTY

Any person or organization violating any of the provisions of this amendment ordinance shall be subject to a fine of not less than one hundred dollars (\$100.00) nor more than five hundred dollars (\$500.00) for each offense.

SECTION 4. OF VALIDITY

If any section, subsection, sentence, clause, or phrase of this ordinance is adjudged to be void, such decision shall not affect the validity of the remaining portions.

SECTION 5 OF REPEAL

All articles, sections, subsections, or parts thereof, in conflict with the provisions of this ordinance, be and the same are hereby repealed to the extent of such conflict.

SECTION 6 OF PUBLICATION

Publication of this ordinance No. 034 A/4 shall be published in pamphlet form, by and under the authority of the Board of Trustees of the Village of Wonder Lake, McHenry County, Illinois.

SECTION 7 RECORD OF ADOPTION

This Ordinance No. 034 A/4 shall be in effect with full force from and after the date of its passage, approval, and publication according to the law.



Be it ordained by the President and the Board of Trustees of the Village of Wonder Lake, McHenry County, Illinois, as follows:

Section 1. Amendment to SECTION 2.7, "The Burning of Refuse"

No person shall cause, suffer, allow or permit grass and/or leaf burning, as defined in this Section, from 10 p.m. Saturdays until 8 a.m. on Mondays. Grass and/or leaf burning shall be allowed at all other times.

For purposes of this Section, grass and leaf burning shall include, but not be limited to, the combustion of lawn clippings and leaves, in such a way that the products of the combustion are emitted to the open air without originating in or passing through equipment for which a permit could be issued by the Illinois Environmental Protection Agency.

Specifically prohibited by this Section are smoldering leaf piles between 10 p.m. on Saturdays and 8 a.m. on Mondays, which by way of combustion emit the products of the combustion into the open air.

Section 2. VALIDITY

If any section, subsections, sentence, clause or phrase of this Ordinance is adjudged to be void, such decision shall not affect the validity of the remaining portions.

Section 3. REPEAL

All articles, sections, subsection or parts thereof, in conflict with the provisions of this Ordinance, be and the same, are hereby repealed to the extent of such conflict.

SECTION 4. RECORD OF ADOPTION

This Ordinance No. 34/A3 shall be in effect with full force from and after its passage, approval and publication according to the law.



BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES  
OF THE VILLAGE OF WONDER LAKE, McHENRY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. AMENDMENT TO SECTION 2.7 "THE BURNING OF REFUSE"

Garbage, rubber tires, or rubber products, asphalt shingles, or asphalt product, paints, plastics or any other materials that emit dense smoke, or gives off obnoxious odors or toxic gases shall not be permitted to be burned anywhere in the Village. It will be unlawful to burn any refuse on the Village roadways.

SECTION 2. OF VALIDITY

If any section, subsection, sentence, clause or phrase of this ordinance is adjudged to be void, such decision shall not affect the validity of the remaining portions.

SECTION 3. OF REPEAL

All articles, sections, subsections, or parts thereof, in conflict with the provisions of this ordinance, be and the same, are hereby repealed to the extent of such conflict.

SUNRISE RIDGE ORDINANCE NO. 034...AMENDMENT /A1 AS ADOPTED:

VILLAGE OF WONDER LAKE, McHENRY COUNTY ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF WONDER LAKE, McHENRY COUNTY ILLINOIS, THE FOLLOWING:

AN ORDINANCE PASSED AND APPROVED BY THE VILLAGE BOARD AND THE VILLAGE PRESIDENT WITH REGARD TO REFUSE, GARBAGE AND RUBBISH DATED JAN. 25, 1979. AND ADOPTED BY THE VILLAGE OF WONDER LAKE BY RESOLUTION TO ADOPT ALL ORDINANCES AND RESOLUTIONS OF THE VILLAGE OF SUNRISE RIDGE IS HEREBY AMENDED TO WIT:

SECTION 1 SECTION 2.3 OF ORDINANCE NO. 034 IS HEREBY AMENDED TO READ:

2.3....ALL REFUSE WHICH IS PLACED FOR COLLECTION SERVICE OUTSIDE ANY BUILDING, STRUCTURE, OR PREMISE, MUST BE KEPT IN STANDARD REFUSE CONTAINERS. STURDY PLASTIC BAGS MAY BE USED OR SET OUT FOR PICK UP, AS AN ALTERNATE STANDARD CONTAINER. A SELF PUMPING CONTAINER SHOULD BE EMPLOYED WHEN REFUSE EXCEEDS AN UNUSUAL NATURE.

SECTION 2. SECTION 2.6 OF ORDINANCE NO. 034 IS HEREBY AMENDED TO READ:

2.6 LOCATION OF REFUSE CONTAINERS:

GARBAGE CONTAINERS MAY BE PLACED NEAR THE ROAD EDGE FOR PICK UP NO SOONER THAN 5 P.M. ((5:00)) ON THE DAY BEFORE PICK UP. CONTAINERS MUST BE PLACED SO AS NOT TO OBSTRUCT TRAFFIC OR MAIL DELIVERY.

ALL REFUSE CONTAINERS MUST BE KEPT WITHIN THE PROPERTY LINES OF SAID INDIVIDUALLY OWNED PROPERTY SO AS NOT TO CREATE AN EYESORE OR HEALTH PROBLEM AND PREFERABLY OUT OF SIGHT OF THE NEAREST ROADWAY OR STREET.

SECTION 3 . OF VALIDITY

If any section, subsection, sentence, clause, or phrase of this ordinance is adjudged to be void, such decision shall not affect the validity of the remaining portions.

SECTION 4 . OF REPEAL

All articles, sections, subsections, or parts thereof, in conflict with the provisions of this ordinance, be and the same, are hereby repealed to the extent of such conflict.

SECTION 5 . OF PUBLICATION







REFUSE - GARBAGE - RUBBISH  
VILLAGE OF SUNRISE RIDGE, McHENRY COUNTY, ILLINOIS

---

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF  
THE VILLAGE OF SUNRISE RIDGE, McHENRY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. PURPOSE

To maintain buildings, structures and premises in connection with any business, occupation, organization or residency in a sanitary, safe and non dangerous condition.

SECTION 2. REFUSE-GENERAL REGULATIONS

2.1 Refuse Disposal

It shall be unlawful for any person, organization, firm or corporation to place any refuse of ~~organic~~ nature, commonly known as "garbage", or any metal, glass, paper, or plastic containers, or any loose papers, ashes or any other ~~inorganic~~ matter of any kind, by dumping or depositing the same, on any premises, streets, alleys or right of ways, parks or other public places or other public or private property whether owned by such person or not, or in any stream or other body of water.

2.2 Refuse Removal and Schedule

It shall be the duty and responsibility of the occupant of every building, structure or premise used or maintained in connection with any business, occupation or residency to cause to be removed at the cost and expense of said occupant at least once a week all refuse produced therein, or the frequency of collection requirements shall be in accordance with the volume of garbage and refuse accumulated as shall be required by the Village Department of Health.

2.3 All refuse which is placed for collection service outside any building, structure or premise, must be kept in standard refuse containers, unless due to the unusual nature of the refuse produced by the business or organization, another type of container is required as approved by the Village Department of Health, or when the standard containers exceeds a suitable number, a self dumping container should be employed. Sturdy plastic bags used as an alternate standard container for garbage (food items) shall not be placed for refuse pick-up at any time prior to five (5) A.M. of the refuse pick-up (collection) day. *Amended 1/27/81*

2.4 Duty to provide Refuse Containers

The occupant of every building structure or premises used or maintained in connection with any business, occupation or residence shall provide and maintain in good condition and repair a sufficient number of refuse containers for the temporary storage of all refuse accumulating between collections.

## SECTION 2. REFUSE - GENERAL REGULATIONS (cont.)

### 2.5 Standard Refuse Containers

The standard refuse container required shall be a receptacle of not less than seventy (70) liters or (18.5 gallons) nor more than one hundred and thirty (130) liters or (35 gallons) capacity, of impervious material and sturdy construction with a tight fitting cover and equipped with handles properly placed and shall be of such weight that they can be handled by one man. Sturdy plastic bags of similar capacity of the standard containers may be used as an alter-

2.6 Location of Refuse Containers inate container unless otherwise  
Standard refuse containers must be out of sight from the street, except for pick-up day. speci-  
fied.

### 2.7 The Burning of Refuse

Garbage, rubber tires, or rubber products, asphalt shingles or asphalt products, paints, plastics or any other materials that emit dense smoke, or gives off obnoxious odors or toxic gases shall not be permitted to be burned anywhere in the Village.

### 2.8 Explosive and Nuclear Refuse

Highly combustible, explosive or nuclear materials shall not be placed in containers for regular collection but shall be disposed of as safety shall require.

### 2.9 Accumulation of Refuse

Any unauthorized accumulation of refuse on any premises is hereby declared to be a nuisance and is prohibited. Failure to remove any existing accumulation of refuse within three (3) days after notice by the Village Department of Health, shall be deemed a violation of this ordinance.

## SECTION 3. REFUSE COLLECTION - TRANSPORT AND DISPOSAL REGULATIONS

### 3.1 Transport Vehicle

Any vehicle that shall be used for transporting refuse shall be covered or enclosed in such a way that the contents thereof will not blow from or drop off of said vehicle either within the Village limits or on the way to the disposal ground or site. All such vehicles shall be subject to inspection by the Village Department of Health.

### 3.2 Unlawful Garbage Transport

It shall be unlawful to carry or transport any garbage from a place of residency or place of business to any container at any park, beach, place of recreation or municipal grounds.

### 3.3 Unlawful Refuse Transport

It shall be unlawful for any person to cast, place, sweep or deposit, anywhere, in the Village, any refuse in such a manner that it may be carried or deposited by the elements upon any street, sidewalk, alley, sewer, parkway or other public place, or into any other premises.

## SECTION 4. PENALTY

Any person, organization, firm or corporation violating any of the foregoing said provisions shall be subject to a fine of not less than ten (\$10.00) dollars nor more than five hundred dollars (\$500.00) for each offense.

SECTION 5 . OF VALIDITY

If any section, subsection, sentence, clause, or phrase of this ordinance is adjudged to be void, such decision shall not affect the validity of the remaining portions.

SECTION 6 . OF REPEAL

All articles, sections, subsections, or parts thereof, in conflict with the provisions of this ordinance, be and the same, are hereby repealed to the extent of such conflict.

SECTION 7 . OF PUBLICATION

Publication of this Ordinance No. 034 shall be published in pamphlet form by and under the authority of the Board of Trustees of the Village of Sunrise Ridge, McHenry County, Illinois.

SECTION 8 . RECORD OF ADOPTION
